
ENROLMENT SCHEME KELBURN NORMAL SCHOOL

Home Zone

All students who live within the home zone described below shall be entitled to enrol at Kelburn Normal School.



Northern Boundary

From the intersection of Glenmore Street and Garden Road to the north end of Rawhiti Terrace.

Eastern Boundary

The zone includes Rawhiti Terrace and continues south to the intersection of Kelburn Parade and Salamanca Road. It then follows, but does not include Salamanca Road, south to the intersection with Mount Street. It follows Mount Street and McKenzie Terrace. From the southern end of McKenzie Terrace it continues to the intersection of Kelburn Parade and Fairlie Terrace (but does not include Fairlie Terrace).

Southern Boundary

From the intersection of Kelburn Parade and Fairlie Terrace the zone continues West to the intersection of Aro Street, Holloway Road and Norway Street (note that Devon Street, Essex St, Fairlie Terrace, Adams Terrace and Aro Street are not included). The zone continues along Holloway Road to its southern end (Haines Terrace and Carey Street are included). The southern boundary continues in a westerly direction to the southern end of Highbury Road. From the southern end of Highbury Road the zone continues west to the southern end of Waiapu Road.

Western Boundary

From the southern end of Waiapu Road the zone continues north to the intersection of Chaytor Street and Curtis Street (note that on the northern side of Chaytor street addresses 38 and above are in zone). The zone continues from the intersection of Chaytor Street and Curtis Street to the intersection of Putnam Street, Northland Tunnel Road and Putnam Link Road (note that addresses 24 and 25 and above Putnam Street are in zone). The zone continues north along Northland Tunnel Road and Northland Road until it intersects with Garden Road. Continue east along Garden Road until it intersects with Glenmore Street (note that on the northern side of Glenmore street, addresses 78 and above are in zone; all addresses on the southern side of Glenmore Street are in zone). Included within the zone is Bank Road and house numbers 10 and 9 and below Orangi Kaupapa Road.

Out of Zone Enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processing in the following order of priority:

First Priority this priority category is not applicable at this school because

the school does not run a special programme approved by

the Secretary

Second Priority will be given to applicants who are siblings of current

students

Third Priority will be given to applicants who are siblings of former

students

Fourth Priority will be given to applicants who are children of board

employees

Fifth Priority will be given to all other applicants

If there are more applicants in the second, third, fourth or fifth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under Section $11\ G(1)$ of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
